NOW, THEREFORE



BE IT FURTHER RESOLVED that the the above surplus property is hereby ordered to be disposed of as indicated above;

ALSO BE IT RESOLVED that the 2003 Ford Crown Victoria (VIN: 2FAFP71W73X108726) is transferred to Non Departmental 001-000-000 and that \$2,313 be transferred from Non Departmental 001-000-000 to the ER&R 502-000-000 Fund to mitigate the financial impacts on the Sheriff Department of retaining the vehicle.
