RESOLUTION NO. 2018-06

Re: Declare two Sheriff patrol vehicles surplus,
establish fair market value and authorize direct sale
to City of Newport

WHEREAS, Pend Oreille County and the City of Newport have terminated their agreement for the County Sheriff Department to provide law enforcement services to the City;

WHEREAS, The Sheriff has determined that two patrol vehicles are surplus to the needs of the Sheriff; and

WHEREAS, the vehicles are surplus to the needs of the County; and

WHEREAS, the City has expressed the desire to purchase two patrol vehicles; and

WHEREAS, the vehicles are currently being managed by the ER&R Fund; and

WHEREAS, Resolution 2016-28, ER&R Policy and Procedures, establishes the procedures for withdrawal of vehicles from the ER&R Fund; and

WHEREAS, Resolution 2016-28, ER&R Policy and Procedures, requires the Board to withdraw vehicles from the ER&R Fund by resolution; and

WHEREAS, procedures for withdrawal of a vehicle from ER&R require use of the ratio of the capital replacement reserve to the total book value; and

WHEREAS, Resolution 2017-13, Vehicle and Equipment Rates – 2018 did not establish the ratio of the capital replacement reserve to the total book value; and

WHEREAS, the 2018 rate calculation procedure found the ratio of capital replacement reserve to the total book value to be 16%; and

WHEREAS, the Fleet Manager and the Undersheriff have determined that the fair market value for the 2013 Chevrolet Tahoe, S-8175, VIN 1GNSK2E01DR158640, fully equipped for law enforcement patrol use, except for radios is \$14,000, not including tax; and

WHEREAS, the Fleet Manager and the Undersheriff have determined that the fair market value for the 2013 Chevrolet Tahoe, S1441, VIN 1GNSK2E00DR114967, fully equipped for law enforcement patrol use, except for radios is \$11,000, not including tax;

NOW, THEREFORE

IT IS HEREBY RESOLVED that S-8175, VIN 1GNSK2E01DR158640, a 2013 Chevrolet Tahoe patrol vehicle, and S-1441, VIN 1GNSK2E00DR114967, a 2013 Chevrolet Tahoe patrol vehicle are declared surplus to Pend Oreille County needs; and

IT IS FURTHER RESOLVED that S-8175 and S-1441 are withdrawn from the ER&R Fund; and

IT IS FURTHER RESOLVED that ER&R shall use 16% as the the ratio of the capital replacement reserve to the total book value; and

IT IS ALSO RESOLVED that direct sale of S-8175, VIN 1GNSK2E01DR158640, and S-1441, VIN 1GNSK2E00DR114967, both 2013 Tahoe's law enforcement patrol vehicles, to the City of Newport for the fair market values of \$14,000 and \$11,000, respectively, not including tax, is authorized.
