If amount is not shown here, multiply and reduce by 20%.

Add \$5.00 to reduce amount if one or two moving violations in past years.

Three or more moving violations in past two years=**No reduction**

Deferred findings is authorized if no moving violations in the past two years, no deferred in the past 7 years, and with **NO COMMERCIAL DRIVER'S LICENSE**. Pay \$175.00 administrative fee within 60 days.

Non-Traffic infractions: Reduce based upon prior same/similar violations, and must provide proof of correction (example: expired registration would need proof of current registration to be eligible for reduction).

Other infractions:

No Insurance: Dismiss if the driver was insured for the cited vehicle at the time of citation. Dismissal fee of \$25.00 to be paid immediately.

1st Offense= \$250 with purchase and proof of current insurance

2nd Offense= \$350 with purchase and proof of current insurance

3rd Offense & 3+= NO REDUCTION

No Valid Operator's License 2nd degree: reduce to \$140 w/proof of valid license in a timely manner

Negligent Driving 2nd degree: First Negligent driving offense reduce to \$337

No Seatbelt: (Child: dismiss infraction with proof of child seat purchase within 7 days).

2+ violations ever=NO REDUCTION

Handicap parking: Dismiss infraction if driver had placard at time of violation.

Dog Violations: Person appearance in court required to mitigate.

Parking (Discover Pass/Snow Pass): Dismiss with proof of pass (if they had it at time violation) Dismiss with \$25 fee if purchased after the violation.

INFRACTIONS THAT CANNOT BE REDUCED:

1. **46.16A.030(4)** Failure to initially register vehicle.
2. **46.19.050(10)** Disable parking violations.
3. **46.55.105(2)** Littering abandoned vehicle.
4. **46.61.210** Failure to yield to the right to approaching emergency vehicle.
5. **46.61.212** Failure to yield to stationary emergency vehicle.
6. **46.61.440** Speed in school zone.
7. **46.61.527** Speed in construction zone.
