Pend Oreille County solicits interest from consulting firms with expertise in HMA testing. This agreement will be for approximately eighteen months in duration with the option for Pend Oreille County to extend it for additional time and money if necessary. Consultants will be considered for the following project.

Pend Oreille County reserves the right to amend terms of this “Request for Qualifications” (RFQ) to circulate various addenda, or to withdraw the RFQ at any time, regardless of how much time and effort consultants have spent on their responses.

Project Description

The work to be performed by the CONSULTANT consists of testing HMA for mix properties and gradations for coverstone. Pend Oreille County at their option, may include inspection for HMA pre-level and BST with coverstone. This project does not have a mandatory UDBE goal. The proposed improvements include HMA pre-level in various locations MP 6.40 to MP 15.52 of Leclerc Road South and Coverstone BST MP 7.88 to MP 13.23 of Deer Valley Road and MP 6.40 to MP 15.52 of Leclerc Road South. The major features of the project are as follows:

- HMA pre-level and BST with coverstone.

Evaluation Criteria
