**RESOLUTION REGARDING APPROVAL OF THE MCKENZIE ROAD PROJECT
PROSPECTUS FOR THE RURAL ARTERIAL PROGRAM**

WHEREAS, pursuant to the provisions of RCW 36.32.120(6), the Board of County Commissioners of Pend Oreille County, Washington has the care of county property and the management of county funds and business, and

WHEREAS, the Board of Commissioners of Pend Oreille County has adopted the Pend Oreille County Six Year Transportation Improvement Program for the years 2020 through 2025 and the 2020 Annual Construction Program, and

WHEREAS, the McKenzie Road project is in the 2020-2025 Six Year Transportation program and the 2020 Annual Construction Program, and

WHEREAS, it is necessary for the County to submit a Project Prospectus to the County Road Administration Board for the McKenzie Road Project, McKenzie Road from milepost 0.50 to 2.27, and

WHEREAS, the Board of Commissioners of Pend Oreille County adopted Resolution R-2020-74 on August 24, 2020 approving a Project Prospectus for the McKenzie Road Project, and the Chair signed the Project Prospectus, and

WHEREAS, it is necessary for the County to revise Project Prospectus for the McKenzie Road Project by adding the project timing.

NOW THEREFORE, BE IT HEREBY RESOLVED, that the Board approves the Project Prospectus for the McKenzie Road Project, McKenzie Road from milepost 0.50 to 2.27 and authorizes the Chair to sign for the Board , and

BE IT FURTHER RESOLVED, that Resolution R-2020-74 be rescinded and the Project Prospectus for the Westside Calispel Project signed August 24, 2020 be voided.

DESCRIPTION OF PROPOSED IMPROVEMENTS - Attach Rating Worksheets

Roadway Structural Section, or Bridge Condition:

The existing BST pavement structure is frost susceptible and load restricted every year. The project will replace the pavement structure with an all weather design: cement treated base, CSTC and 3" of HMA.

Horizontal Alignment:

The existing substandard curves will not be corrected with this project.

Vertical Alignment:

The existing vertical alignment is flat and no change is proposed.

Width:

The McKenzie and Beaman Rd. intersection will be realigned to improve sight distance and intersection angle. Make geometric improvements to the McKenzie Bennet intersection.

Other: Clear Zone, Slopes, Guardrail, Illumination, signals etc.:

The intersection geometry of Bennett Rd and McKenzie Rd will be improved.
