WHEREAS, the Board of County Commissioners awarded the contract to Wood's Crushing & Hauling, Inc.; and



## 2020 Maintenance Gravel

THIS AGREEMENT made and entered into this 8 day of September, 2020 between the Board of County Commissioners of Pend Oreille County, State of Washington, acting under and by virtue of Title 36 Revised Code of Washington, as amended, hereinafter called the Board, and Wood's Crushing & Hauling, Inc. for themselves, their heirs, executors, administrators, successors and assigns, hereinafter called the Vendor.

### WITNESSETH:

That in consideration of the payments covenants and agreements, hereinafter mentioned, to be made and performed by the parties hereto, the parties hereto covenant and agree as follows:

- I. The Vendor shall do all work and furnish all materials and equipment necessary to construct, improve and complete the 2020 Maintenance Gravel Materials purchase, in accordance with and described in the Request for Quotes dated August 3, 2020 and the quote submitted by the Vendor, dated August 15, 2020, now referred to and by such reference made a part hereof as fully for all purposes as if here set forth at length, and shall perform any changes in or addition to the work provided under this Contract and every part thereof. The Vendor shall provide and bear the expense of all equipment, work and labor of any sort whatsoever that may be required for the transfer of materials and for completing the work provided for in this Contract and every part thereof, except such as are mentioned in the Specifications.
- II. The County hereby promises and agrees with the Vendor to employ and does employ the Vendor to provide the materials and equipment to do and cause to have done the above described work and to complete and finish the same according to the Plans and Specifications and the terms and conditions herein contained and hereby contracts to pay for the same according to the Specifications and the attached schedule of unit or itemized prices, at the time and in the manner and upon the conditions provided for in this Contract and every part thereof.

The County further agrees to employ the Vendor to perform any changes in or additions to the work provided for in this Contract that may be ordered and to pay for the same under the terms of this Contract and the attached Plans and Specifications.

- III. The Vendor for himself/herself and for his/her heirs, executors, administrators, successors and assigns, does hereby agree to the full performance of all the covenants herein contained upon the part of the Vendor.

- IV. It is further provided that no liability shall attach to the County, by reason of entering into this Contract, except as expressly provided herein, the Vendor agrees to protect and indemnify the County in regard to claims of any nature that may arise during the course of this project.
- V. The Vendor shall provide the following required items prior to a Notice to Proceed being issued:
  - a. Current W9
- VI. The awarded contract bid price: \$7.50 Per Ton
